Set-up time can take place Friday evening or Saturday & Sunday morning vendors are required to be **ready to sell by 10am**. Vendors must be fully set up before their opening time and remain open for the full duration of each day. Early breakdown is not permitted.

Space Cost 10' x 10' Vendor Space (Two Days): \$200

Woodstock Area Chamber Members will receive a 20% discount : \$160

A non refundable \$25 application fee is required. After you're notified of acceptance a 50% deposit is required to secure your space.

Applicants Release (Art Vendors):

Applicant's release, assumption of risk, and agreement to indemnify. If I am chosen to participate in the 2026 show: (a) I, for myself and my personal representatives, executors, administrators, heirs, successors, and assigns, release and discharge The Village of Woodstock, Woodstock Chamber of Commerce, and each of their parent companies, subsidiaries, affiliates, directors, officers, trustees, officials, members, employees, volunteers, agents, attorneys, successors, and assigns, all referred to as "releases," from all liability for any injury, damages, death, property damage, or other loss based upon, arising out of, or in any way connected with my participation in the Woodstock Arts Festival show, whether caused by any of the releases' negligence or any other acts or omissions; (b)

I agree to indemnify each of the releases from any loss, liability, or damages which any of them may incur based upon, arising out of, or in any way connected with any of my acts or omissions that relate in any way connected with any of my acts or omissions that relate in any way to the Bookstock Event; (c) I assume full responsibility for the risk of any injury, damage, death, property damage, or other loss based upon, arising out of, or in any way connected with my participation in the Bookstock Event, whether caused by any of the releases negligence or any other acts or omissions; and (d) I agree that the preceding paragraphs 3 (a) through (c) are intended to be as broad and inclusive as permitted under Vermont law and that if any portion of any or all of those paragraphs is held invalid, the balance of them and this agreement will continue in full force and effect. I agree to assume the risk if the event is canceled for reasons such as weather, terrorism or other Acts of God beyond the control of the Woodstock Chamber of Commerce and the Bookstock Event and if canceled the fee will not be refunded.

4. I have carefully read this application and agreement, including the release, assumption of risk, and indemnity paragraphs, know the contents, and sign this application.
5. I agree this is a “family friendly” event. If artwork is found to be offensive to Woodstock Area Chamber of Commerce Board members or the Bookstock Event Committee such art work will be removed from display.
